ARTICULATION AGREEMENT Between Recruiting and Retention College, Fort Knox, Kentucky and Post University

1. Purpose of Articulation Agreement. This agreement establishes the terms for the renewal of the Articulation Agreement¹, dated 15 July 2021, awarding of academic credit by Post University (OPIED 00140100) for enlisted and commissioned personnel attending the Recruiting and Retention College (RRC). The applicable courses and associated credit are identified in Annex A.

3. The Program.

- a. <u>Availability of Information</u>. Consistent with established Army University policies, Army University will list Post University on The Army University's website for Continued Education Degree Program (CEDP) to inform Soldiers of the Articulation of Understanding with Post University the awarding of course credit agreement. Army University will refer interested students to the Army University's webpage covering this agreement. Post University will establish a webpage for interested students showing the degree options and contact information for counselors/liaisons. Neither listing will state or imply that the US Government, Department of Defense, or any government entity endorses Post University.
- b. <u>Funding.</u> Post University will ensure participating Soldiers are aware of all fees and charges before they register. Soldiers who participate are personally responsible for paying all costs associated with their participation. This agreement does not establish any additional programs wherein the Army or Army University will fund a Soldier's participation. Soldiers who participate are responsible for determining their eligibility for Tuition Assistance or other official educational benefits.
- c. <u>Course Credit and Degree Plans.</u> This program is designed to assist participating Soldiers with obtaining a degree from Post University by obtaining academic credit from their military education and experience. This program includes the following degree programs: Certificate of Human Resource Management, Associate of Science Degree in Management,

Bachelor of Science Degree in Business Administration, Bachelor of Science in Management, Bachelor of Science in Human Resource Management, and Bachelor of Science in Sport Management. To obtain a degree, participating Soldiers must complete all additional general education courses, elective courses, and core courses required for the degree. Annex A identifies the available degree programs and the amount of credit that can be earned toward it from each Recruiting and Retention College, or other military course.

- d. <u>Program Commitment.</u> Post University commits to providing eligible Soldiers the credit as outlined in Annex A. Once a Soldier enrolls, the number and type of credit outlined in Annex A at the time of enrollment will not change to the detriment of the Soldier, regardless of whether the parties to this agreement later renew, modify or terminate this agreement in whole or in part. Once the Soldier pays all associated costs, the appropriate credit will be added to the Soldier's official Post University transcript. Recruiting and Retention College commits to advertising this agreement at appropriate Education Centers and other locations on the installation as well as on appropriate websites as permitted by Army regulations and policy.
- e. <u>Student Responsibilities.</u> The Student must have completed courses identified in Annex A that they are seeking course credit for and present a Joint Service Transcript (JST) as well as course completion certificates in order to receive credit for the courses outlined in this Articulation of Understanding. The Student must additionally meet all of the admission requirements for the desired program at Post University.
- 4. Effective Date and Termination. This renewal will be effective from the date of signature by the Commandant of Recruiting and Retention College and representative of Post University and will have a duration of three years. Upon expiration, it will be subject to renewal. Additions and changes to this MOU may be made at any time with the written agreement of both Post University and Recruiting and Retention College. Additions and changes to this Articulation Agreement may be made at any time with the written express of both Post University and Recruiting and Retention College. Either party may terminate this Articulation Agreement upon 60 days written notice to the other party made to the institutional contact address, via U.S. Certified mail. Termination must be in writing and signed by the approving officials or their successors. Students currently enrolled as outlined in paragraph 3(d) above, will not be detrimentally impacted by any subsequent modifications or terminations to this Articulation Agreement.
