Post University's Policy

Post University is committed to providing a learning, working and living environment that is open, supportive and safe. As a community, this University will not tolerate sexual misconduct of any kind. Post University expressly prohibits the sexual/gender-based misconduct noted below, and students found engaging in it will be subject to University action, and may also be subject to criminal charges and prosecution under Federal and State laws.

What is Sexual/Gender-Based Misconduct?

Sexual misconduct includes a range of behaviors such as sexual harassment, sexual assault, sexual exploitation, stalking, and intimate partner violence.

Consent:

- An affirmative, conscious decision
- Indicated clearly by words or actions
- Cannot be given if a person is incapacitated (e.g. unconsciousness, intoxication, physical force, psychological health condition)

Sexual Harassment:

- Making of unwanted sexual advances, request for sexual favors and other verbal or physical conduct of a sexual nature
- Conduct that interferes with work or education environment

Sexual Assault:

- Non-consensual sexual contact
- Includes fondling, forced sexual intercourse, statutory rape
- Can be committed by an acquaintance or a stranger

Sexual Exploitation:

- Taking nonconsensual, unjust, or abusive advantage of another person in a sexual or intimate context
- Includes sexting, slandering or prostituting another person

Stalking:

- Repeated and unwanted attention, harassment, contact or any other course of conduct directed at a specific person that causes fear in another person
- Includes communications by phone, mail, email, text, social media

Intimate Partner Violence:

- Abusive behavior against an individual by a person in a current or former dating relationship
- Can be physical, sexual, emotional, economical, or psychological actions or threats

What to do if you or someone you know experiences sexual/gender-based misconduct?

1) Get Support and Help

- Get medical attention to treat injuries and to protect yourself from sexually transmitted diseases or pregnancy, as well as to collect evidence should you choose to report the matter.
- Contact resources on and off campus (see chart on back page).

2) Report to the University

Post University encourages students to report an incident of sexual/gender-based misconduct. You have multiple reporting options:

- **Confidential:** your report will not go beyond the person you are reporting to. These sources will NOT notify any other personnel unless you are in danger of harming yourself and/or others. This includes counselors and health professionals.
- **Limited Confidential:** your report will be shared with the Title IX Coordinator. Any other report sharing will be limited, based on your safety and the safety of the community. This includes instructors, advisors and Campus Life staff.
- **Report directly to the Title IX Coordinators.**
- **Anonymous:** your report will be sent to the University's Director of Title IX and Disability Services, Jennifer Labate, JLabate@Post.edu and 203.596.6027.

3) Report to the Police

The police department is available for individuals who would like to report the assault and possibly initiate a criminal investigation.

Other Title IX Protections

Gender Identity

Post University supports all students' rights to express their gender identity in an environment free from harassment and discrimination. Students may opt to identify themselves with a chosen name rather than their legal one; utilize the bathroom specified for their gender identity; and select housing options based on their gender identity.

Pregnant and Parenting Students

A student may notify the director of Title IX and Disability Services for assistance seeking academic support, leaves of absence, and other reasonable modifications for pregnancy, related medical conditions, childbirth, termination of pregnancy, recovery from childbirth, and lactation.
